

# ASSEMBLY CHRISTIAN SCHOOL

## **PARENTAL AGREEMENT**

(Complete one per family.)

### **TUITION PAYMENT**

Because assembly Christian School has an obligation to its employees, students are considered enrolled for the entire school year. Tuition is calculated on the basis of the entire year; therefore, no reductions can be made for vacations or school holidays. If a student enters after the school year has begun, then charges are pro-rated according to actual number of days enrolled. No deductions will be made from tuition for absences during the school year, regardless of the cause of such absence.

### **DISCIPLINE**

I understand that sending my children to Assembly Christian School is a privilege and not a right. The goals of Assembly Christian School are not to reform, but to train Christian youth in the highest principles of Christian leadership, self-discipline, individual responsibility, personal integrity, and good citizenship.

I also believe that discipline is necessary for the welfare of each student, as well as for the entire school. I give permission for my child's teacher and/or other agent of the school to make and enforce classroom regulations and school policies in a manner consistent with Christian principles of discipline as set forth in the Scripture. This may include such measures as instruction, exhortation, correction, rebuke and contacting parents.

### **ACTIVITIES**

I hereby grant permission for my child to use all of the play equipment and participate in all of the activities of the school (unless restrictions are listed). I understand that I may be required to sign permission slips for specific activities before my child will be allowed to participate.

### **WITHDRAWAL NOTICE**

I agree that should I choose to withdraw my child, whether before the school year begins or during the year, I will request and complete the *Request for Withdrawal Form*. The withdrawal will be effective as of the date the completed form is submitted to the office. Parents are responsible to pay tuition for the entire month in which the withdrawal occurs regardless of how many days the student was enrolled. **I understand that ACS will not send transcripts or records to any other schools unless all accounts are paid in full.**

### **LOCKERS/DESKS**

I understand that school lockers and desks are property of the school and that the school has a right to open and search desks and lockers. The school is not responsible for items lost or stolen.

### **WAIVER AND RELEASE**

I further agree to hold the school and its directors, officers, employees, volunteers, agents, related entities and successors (collectively, the "ACS Releasees") harmless for any liability claims and demands of any kind or nature, which exist now or in the future in connection with my child's enrollment in the school. I understand and agree that this release discharges the ACS Releasees from any liability or claim that I or my child have against ACS with respect to bodily injury, illness, death, property damage or any other harm that may result from my child's attendance at the school, including harm caused by the negligence of ACS. Should legal action for any reason be taken against ACS Releasees on my child's behalf, I agree to pay any attorney fees, court fees, damages, or other costs that Assembly Christian School or its agent should incur to defend itself against such action.

**DURATION/EFFECT OF PARENTAL AGREEMENT**

This Parental Agreement Statement will be in effect for as long as my children listed or others are enrolled and/or attend Assembly Christian School, whether it be Preschool, Elementary, Junior or Senior High.

I understand that should my marital status change, it is my responsibility to have a corrected Parental Agreement Statement signed and updated and delivered to Assembly Christian School.

I realize that Assembly Christian School is an extension of me, the parent, and I pledge my prayerful support to the school administration and faculty. I will make every effort to work with the school personnel to insure the best possible learning experience for my child.

**EMERGENCY CARE / USE OF INFORMATION**

I consent to the provision of medical treatment to my child in the event of illness or injury and to the transportation of my child to the nearest medical facility for medical care if necessary, and I release and forever discharge the ACS Releasees from any liability or claim whatsoever which arises or may later arise on account of any medical services rendered or transportation to any medical facility in connection with a medical emergency during my child's enrollment in and attendance at ACS.

**PHOTO AND MEDIA RELEASE**

I grant to ACS all right, title, and interest in any and all photographs, images, video, or audio recordings of my child or my child's likeness or voice made by ACS in connection with his or her enrollment in and attendance at ACS. I understand and agree I will not receive any compensation for the use of such material.

**BROAD RELEASE INTENDED**

I expressly agree that the release included in this Parental Agreement are intended to be as broad and inclusive as permitted by the laws of the State of Louisiana and that these releases shall be governed by and interpreted in accordance with the laws of the State of Louisiana. I further agree that in the event of any clause or provisions of these releases are deemed invalid, the enforceability of the remaining provisions of these releases shall not be affected.

**CODE OF CONDUCT**

**As a parent/guardian I am in agreement with the Assembly Christian School Handbook and Code of Conduct, and understand that I am to cooperate with the school according to the policies and regulations contained therein, along with any other school policies, both verbal and written.**

**ACKNOWLEDGEMENT**

As the parent\guardian, I grant ACS the authority to contact my child's previous school(s) in an effort to confirm and/or clarify educational records including but not limited to report card grades, results of standardized testing, and/or behavioral\disciplinary records. Furthermore, the administrators of ACS have my permission to speak to an administrator\teacher of said school(s) concerning my child's educational/ disciplinary history and receive copies of such information if deemed necessary.

I have read and do understand the above information, and in consideration for the right of my child to attend Assembly Christian School, I in good faith make the releases and waivers included in this Parental Agreement and assume the responsibilities contained herein.

I have read and do understand the above information and request that my child be accepted to attend Assembly Christian School.
